OCTAL PET HF R1

HF D1 is a food grade PET resin, suitable for hot fill beverage containers. Developed and engineered for fast crystallization during the blow molding process, HF D1 also possesses higher heat resistance, dimensional strength and mechanical properties. A low degree of crystallinity and heat of fusion are some of the advantages of OCTAL PET HF D1 that save energy and reduce regeneration of acetaldehyde during downstream processing. The spherical pellets of the resin ensures smooth conveying in long pipelines with near zero fines generation. The uniform spherical surface allows for easy flow of air around the PET pellets and helps in consistent drying at lower temperatures, saving valuable energy.
